From bottom up: 38 jts AO Smith, 132 jts J-55. Total tallies 7347', H-12, set @ 7359'. Cemented by Halliburton with 575 sacks of 2% and 125 sacks of neat bulk cement. Plug @ 7309'. Job started @ 4:30 p.m. and completed @ 7:00 a.m.
