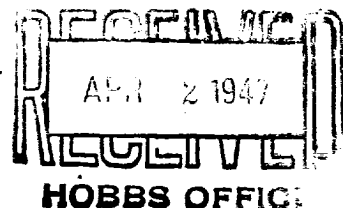

### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

At 7:30 p.m. March 28th 48 hours had elapsed since setting 2853' of 9-5/8" 32.3# casing and cementing with 1500 sacks. At this time casing shut off was tested as follows:

A pressure of 750# was built up and held for thirty minutes and as shut-off tested OK cement plug was drilled and a pressure of 750# again built up and held for thirty minutes. If this test, too, was OK, drilling operations were resumed.
