## FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Brinkard production has declined to 2 BOPD. Since it is uneconomical to produce and workever possibilities have been exhausted. It is proposed to abandon the Brinkard interval and attempt recompletion in the Paddock formation. Logs will be run, Brinkard formation will be abandoned by setting drillable bridge plugscapped with 20 feet of cement at approximately 6350 feet and 5400 feet and the interval between filled with mud. Interval to be perforated will be determined after review of logs and acidised with 3500 gallons 15% LSTHE acid and tested.
