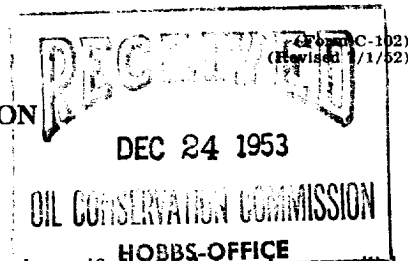

FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to dual complete the above well as a gas-oil well the following work is proposed:

Pull tubing and perforate the Tubbs formation at the following intervals with 2 jet shots per foot 6070 - 6175; 6194 - 6206; 6224-6236; 6256-6274; 6294-6300; 6309-6321. Set Baker retainer Production Packer on wireline at 6450, and selectively stimulate the perforated intervals with 10,000 gal 15% reg. acid. Completions will be in accordance with plan previously submitted with our letter dated 12-4-53. File KJB-3094-401.
