2. At least 72 hours prior to the commencement of any packed leakage test, the operator shall notify the Commission in writing of the exact date the test is to be conducted. Offset operators shall also be so notified.

3. The packed leakage test shall commence when both zones of the dual completion are suitable for pressure stabilization. Both zones shall remain suitable until the well-head pressure in each has stabilized and for a minimum of two hours, or longer, provided however, that they need not remain suitable more than 24 hours.

4. For flow Test No. 1, one zone of the dual completion shall be produced at the normal rate of production while the other zone remains shut-in. Such test shall be continued until the flowing wellhead pressure has become stabilized and for a minimum of two hours thereafter, provided however that the flow test need not continue for more than 24 hours.
