(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to stimulate production we propose the following:

Clean out to 5194. Re-Perforate 5140-5156 and 5168-5176 with two shots per foot; perforate new intervals 5156-5168 and 5176-5194 with 4 shots per foot. Run tubing and acidise down tubing with 10,000 gallons of regular acid containing 0.5% Unisol, flush with approximately 50 barrels of oil, test and return well to production.
