Cleaned out, frac treated and repaired leak in 6" casing as follows:

-

- 1. Pulled tubing.
- 2. Ran Steel line measurement. Found top savings at 3733'. Cleaned out with sand pump to 3740' (TD).
- 3. Treated open hale formation from 3575-3740' with 8000 gallons oil fras containing Adomite with 1# sand per gallon.
- 4. Well Kicked off. Recovered all load oil. Flowed 106 bbls oil, 26 bbls water in 24 hours.
- 5. Killed well. Pulled tubing. Ran 6" Baker Model K DM bridge plug on wire line set at 3560". Ran HRC tool. Found leak in casing at 530". Comented thru leak with 300 sacks regular cement. Circulated 25 sacks cement thru 9-5/8" bradenhead. Glosed 9-5/8" bradenhead and squeesed with 800#.
- 6. WOC.
- 7. Drilled cement out to 600'. Tested with 500# for 30 minutes. No drop in pressure. Drilled cement and bridge plug from 3549-3565'. Cleaned out to total depth.
- 8. Returned well to production.
