In order to increase production, it is proposed to plug back and acid treat as follows:

1. Pull tubing.
2. Plug back with 20-40 and 40-60 mesh sand in open hole from 5180-5140'.
 Dump hydromite on top of sand from 5140-5130'.
3. Run 2-3/8" tubing. Acid treat with 5000 gallons 15% N² acid from 5065-5130'.
 Swab and test.
