FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

This well was drilled to a total depth of 6572'. 5-1/2" casing was set and cemented to 6572'. The well was completed as an oil well through casing perforations from 6420' to 6480' and from 6500' to 6560'. Upon initial test, the well produced at the rate of 624 barrels per day with a gas oil ratio of 762. The accompanying plat gives our interpretation of the depth and location of wells completed below the San Andres productive horizon. Circled in red are those wells which we understand have found their production from the Drinkard-Yaso horizon. It will be noted that all such wells are more than 2 miles distance from the Hardison well.
