(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Dual complete as Tubb gas - Drinkard oil.

1. Squeeze off upper Drinkard perforations 6375-6435.
2. Drill out and test lower Drinkard perforations 6465-6565 (Present producing interval)
3. Perforate Tubb gas 6145-6190; 6090-6125; 6015-6058.
4. Stimulate Tubb with acid wash and sand-oil frac.
5. Test Tubb.
6. Make tubing and well head arrangement to produce Tubb through casing annulus and Drinkard through tubing.

Present producing interval: Drinkard 6465-6565.

Current test: 16 bbls. FLO/day; GOR - 6396; 10/64" choke; T. P. - 300#.
