FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Well was drilled to a total depth of 6535' in lime. Ran Schlumberger survey and measurements checked. Ran 6401' of 5 1/2" OD casing and set at 6410'. Used Baker Triplex float and guide shoe with cement retainer and cemented with 380 sax. Plug down at 6:00 a. m. August 12, 1946.

This production string shall be permitted to stand at least 48 hours before testing casing. It is planned to test the casing at 1:00 p. m. August 14, 1946.
