Gentlemen:

The above-referenced well was recompleted from the Tubb Oil and Gas Pool to the Blinebry Oil and Gas Pool effective November 1, 1988.

Due to the recompletion of the Mark Owen #4 in Unit J of Sec. 34, to the Blinebry Pool it will be necessary for you to request that the 160 acre NSP-841 dedicated to your Mark Owen #3-I be reduced to 120 acres.

A Blinebry oil allowable has been assigned to Mark Owen #4 and the acreage dedicated to your Mark Owen #3 Blinebry Gas well has been reduced to 120 acres and you will have 60 days in which to get your 120 acre NSP approved.

Please furnish this office with a copy of your NSP application in order that we will know that you are working toward obtaining approval of the reduced NSP.
