Gentlemen:

Forwarded herewith in duplicate, is our application for authority to effect a dual completion in the Blinebry gas and Wantz Abo oil pools in our Lockhart B-35 Well No. 2 in Unit B, Section 35, Township 21 South, Range 37 East, Lea County, New Mexico. This well was formerly a Blinebry gas, Drinkard oil dual completion, and in 1964, was recompleted as a Blinebry oil, single producer. On July 1, 1965, the well was reclassified as a Blinebry gas well. It is proposed to squeeze the Drinkard perforations, deepen the well to the Abo, set and cement a liner, and perforate selected intervals in the Abo formation.

In anticipation of the necessity to produce the lower formation by artificial lift, we are planning to run a vent string to permit efficient use of a bottom-hole pump. It is considered impractical to run an additional string of tubing for the Blinebry gas completion. The Blinebry zone in this well was produced for a number of years without tubing, and the well performed very satisfactorily. Consequently, it is respectfully requested that an exception be granted to Rule 107(d)(2). New Mexico Oil Conservation Commission Page 2
