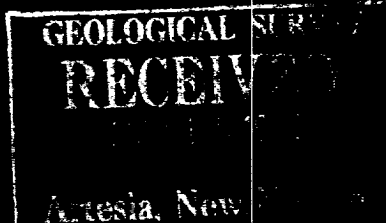

DETAILS OF WORK

Well plugged and abandoned as follows: Loaded hole with mud and plugged with 100 sacks cement from 9954' to 9654'. Plugged from 7750' to 7553' with 200 sacks cement. Set 7" casing at 7553'. Cemented with 150 sacks cement. Cement outside casing came up to 6930'. Plugged top 3287' of 7" casing and cemented with 80 sacks cement from 3286' to 3126'. Placed 25' cement plug in top of 9-5/8" casing and installed regulation well marker.
