Gentlemen:

Under provisions of Order No. R-316, Rule 112-A of the Commission's Rules and Regulations, Stanolind Oil and Gas Company makes application for administrative approval to dually complete and produce its State "C" Tract 13 Well No. 8, NW/4 of NW/4 of Section 36, Township 21-S, Range 37-E, Lea County, New Mexico. This dual completion will be effected using procedure to allow gas from the Tubb formation to be produced through the casing-tubing annulus, and oil from the Drinkard formation through the tubing by selective perforation and installation of suitable packer equipment.
