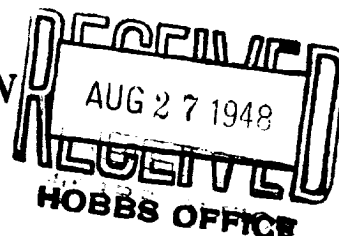

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On August 9, 1948, at 4:00 AM, 30 hours had elapsed since running 3795 feet of 9-5/8" new casing in subject well and cementing with 1800 sacks used as intermediate string. At this time casing shut off was tested as follows:

A pressure of 1000# was built up and held for 30 minutes, testing OK. Cement plug was drilled and a pressure of 1000# was again built up and held for 30 minutes. This, too, tested OK. Drilling operations were resumed.
