DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was drilled to a TD of 345' in Red Bed. Ran 8 jts (319.15') 13-3/8" OD 54.5# 8R AO Smith csg set at 337.6' and cemented with 350 sax. Cement circulated. Plug was down at 3:20 AM 6-19-52. Cement was allowed to set 24 hours. 1000# pressure was applied w/all valves closed with no drop in pressure. Test was satisfactory and drilling was resumed.
