DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Byers No. 3 was drilled to a total depth of 335' in red bed. Ran 10 jts or 316.85' of 13 3/8" OD 48, 8rd thd SS casing set at 333' and cemented with 350 sacks regular neat cement. Cement circulated. Plug down 8:45 P.M. February 1, 1953. Cement was allowed to set 24 hours, 1000# pressure was applied with all valves closed with no drop in pressure. Test was satisfactory and drilling was resumed.
