Recovered 4790' Fluid, 9 stands mud, 3 stands fresh water, 41 stands sulfur water. Places 15 sacks common cement. Found top plug 5606'. Made D. S. T. Packer set at 5560'. Open 90 Min. Recovered 1920' Fluid. 1 stand mud, 20 stands sulfur water. Placed 18 sacks common cement. Found top plug 5522', drilled to 5545' Ran D. S. T. Packer Set at 5500'. Open 240 Min. Recovered 3913' Fluid, Fresh water on top, sulfur water on bottom. Placed 17 sacks common cement. Drilled plug to 5500' Ran D. S. T., Set packer at 5430'. Open 120 Minutes, Recovered 650' salt and sulfur water.
