Plan to MIRU pulling unit & install BOP. TIH w/gauge ring & junk basket & clean fill if necessary to 7900'. Run CRN/CCL log fr. 7850' to 3600'. TIH w/CIBP set at 7850'. Run pkr. set at 7800' & test CIBP to 1000#. Open pkr. by-pass & test csg. to 1000#. Recover pkr. & dump 4 sks. cement on top of CIBP & WOC. Abandon McKee Zone. Run 4" csg. gun & perforate Nadine Tubb Zone 5-1/2" csg. w/2SPF according to CRN log. TIH w/pkr. & acidize above Nadine Tubb Zone perms w/100 gal. 15% NEFE HCL acid per ft. perforated interval. Swab load & evaluate production potential.
