3695' - Total Depth - Lime - Finished drilling 11" hole @ 9:15 AM, 9/30/52 - Ran a total of 87 Jts of 8-5/8" OD casing set @ 3695' w/1700 Sax cement. Plug to 3610' @ 8 PM, 9/30/52. Max press. 800#. Ran temperature survey, found top of cement outside 8-5/8" casing @ 1177' or 42.7% fill. After WOC for 24 hours, tested 8-5/8" casing for 1/2 hour w/1000# - no pressure drop. Drilled cement from 3610' to 3695' and tested 8-5/8" OD casing w/1000# for 1/2 hour - no pressure drop. Started drilling formation and 7-7/8" hole @ 10:15 AM, 10/2/52 -
