**3705' - Total Depth - Lime. Ran Temperature Survey - Found top of cement outside 8-5/8" casing at 1224' - Ratio of actual to calculated fill, 58.1%. Checked top of cement inside 8-5/8" csg at 3616'. Tested 8-5/8" casing with 800# for 1/2 hour - no pressure drop. Drilled cement from 3616' to 3705' and tested casing with 800# for 1/2 hour - no pressure drop. Started drilling formation and 7-3/8" hole at 8:45 AM, 1/24/52.**
