

**3710' - Total Depth - Lime - Did not run Temperature Survey - Cement Circulated. Picked up 2-7/8" Drill Pipe with 4-3/4" Bit - Checked top of cement inside 5 1/2" casing at 3635'. Tested casing for 1/2 hour with 800# - No pressure drop. Drilled cement from 3635' to 3710'. Tested 5 1/2" casing for 1/2 hour with 800#, - no pressure drop. Will drill approximately 200' and complete well in open hole.**
