Ratio of actual to calculated fill, 84.4% Checked top of cement inside 5 1/2" casing at 9277', and tested casing with 1000# for 1/2 hour - no pressure drop. Drilled cement from 9277' to 9312' and tested casing for 1/2 hour with 1000# - no pressure drop. Continued with completion operations.
