3703' - Total Depth. Lime - Finished drilling 11" hole @ 8 PM, 4/15/53 - Ran a total of 101 Jts of 8-5/8" OD casing set @ 3 702' W/1500 Sx. Pumped plug to 3633' at 7 AM, 4/16/53 - Max pressure 800#. Ran temperature survey - top of cement outside 8-5/8" OD casing @ 1180', or, 43.3% fill. - After WOC for 24 hours, tested casing for 1/2 hour W/1000# - no pressure drop. Drilled cement from 3628' to 3703' and tested casing for 1/2 hour W/1000# - OK Started drilling formation and 7-7/8" hole @ 3703' at 6 PM, 4/17/53.
