DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

It is our intention to drill a well at above location to a depth of approximately 3700' with rotary tools, and to drill through pay zone to a total depth of approximately 3910' with reverse circulation rig. It is proposed to test the well naturally and if necessary the pay will be shot with approximately 250 qts. SNG, and the hole cleaned out after shot to total depth. All casing points will be cemented in accordance with approved methods of the U.S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing pattern: 10 3/4" casing to be set at approximately 250' and cemented with 250 sacks, cement to be circulated to surface; 7" casing to be set at approximately 3700' and cemented with approximately 1570 sacks cement, or sufficient cement to protect the salt section.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
