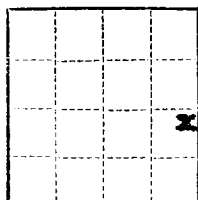

DETAILS OF WORK

It is our intention to drill a well at the above location to a total depth of approximately 9250' with rotary tools in order to continue development of McKee oil reserves and to meet demands of the USGS for further development of federal leases comprising the Southeast Monument Unit. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing pattern: 10 3/4" to be set at 250' and cemented with approximately 250 sacks, cement to be circulated. 7 5/8" to be set at 4000' and cemented with approximately 1875 sacks. 5 1/2" to be set at 9250', cemented with approximately 450 sacks and to be perforated opposite the pay zone.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

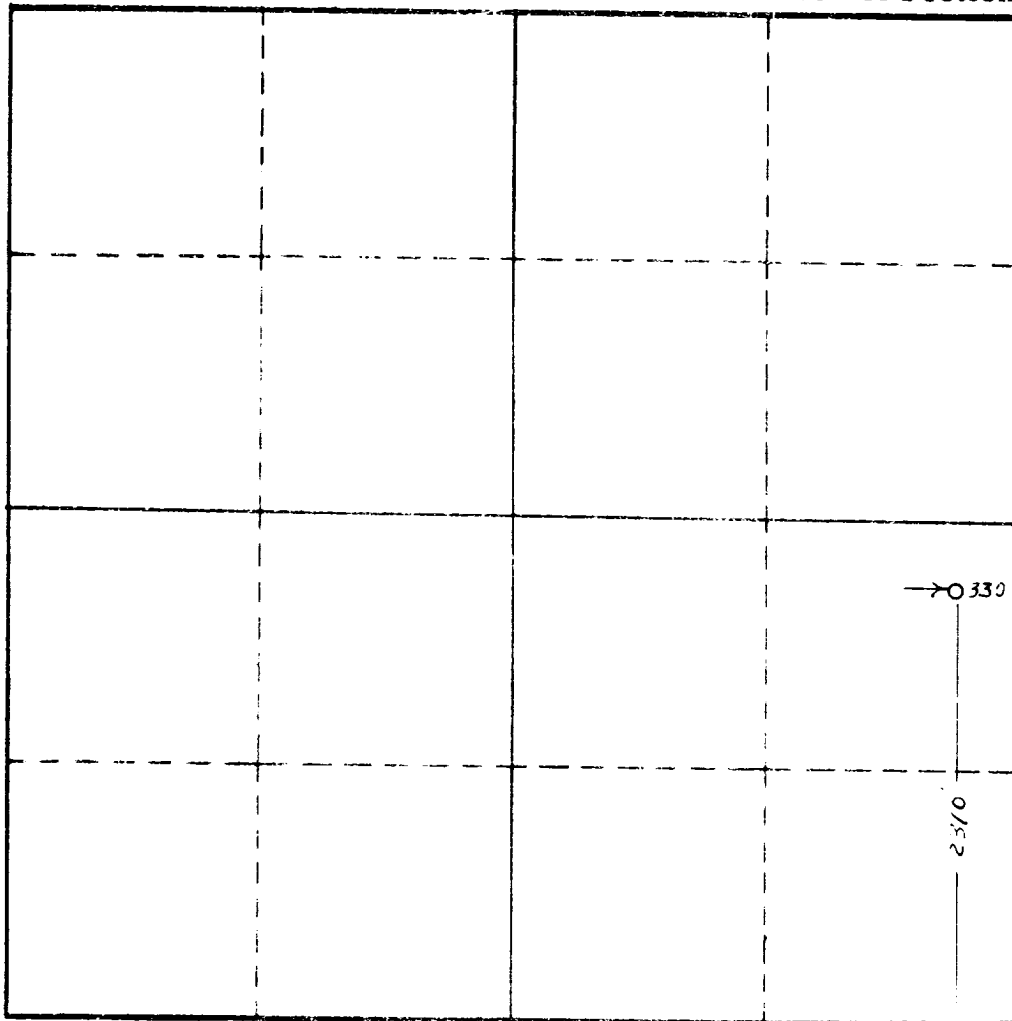
