It is proposed to perform the following operations in order to prepare this well for temporary abandonment:

1. Pull out of hole w/production tbg.
2. Trip in hole w/bit & scraper to 8440'. Set RBP @ 8440'.
3. Circ pkr fluid & press test csg to 500 PSI for 30 mins.
Notify BLM 24 hrs prior to pressure testing.
4. POOH w/bit & scraper & top off wellbore w/ pkr fluid.
