Re: Application of Continental Oil Company for administrative approval of dual completion in the Warren-Elinebry Gas Pool and the Warren-Tubb Gas Pool of its Warren Unit Well No. 10 located in Section 23, T-208, R-33E, NMPM, Lea County, New Mexico.

Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 112-A of the Rules and Regulations of the New Mexico Oil Conservation Commission as revised in Order R-1214 for the dual completion of its Warren Unit Well No. 10, located 660 feet from the North and 2310 feet from the East lines of Section 28, T-208, R-38E, NMPM, Lea County, New Mexico, for the production of gas from the Warren-Blinebry Ges Pool and gas from the Warren-Tubb Gas Pool, and in support thereof states:

- 1. Applicant is co-owner and operator of the Warren Unit which contains, in addition to other lands, Section 28, T-208, R-38E, NMPM, Lea County, New Mexico.
- 2. Applicant drilled and completed on December 4, 1952, its Warren Unit Well No. 10 as an oil well in the Drinkard formation at a location 660 feet from the North and 2310 feet from the East line of said Section 28.
- 3. That production from said well has declined to such a rate that applicant proposes to plug off the Drinkard formation and dual complete in the Tubb and Blinebry formations.
- 4. That said well is within one mile of the Applicant's Werren Unit Well No. 8, a dual completion in the same Tubb and Blinebry zones, which is located within the defined limits of the Warren-Blinebry and Warren-Tubb Gas Pools.
- 5. Applicant proposes to utilize parallel strings of tubing to produce the hydrocarbons from the two zones safely and efficiently. Production from the Tubb will be through 2" KUE 4.7 lb. tubing and from the Blinebry through 2" Hydril 4.7 lb. tubing.
- Applicant proposes to use a permanent type production packer to segregate the separate producing zones of the dual completion.
- 7. Applicant proposes to dedicate the NE 1/4 of said Section 28 for the formation of a 160-acre unit for production of gas from the Warren-Tubb Gas Pool, and for the formation of a 160-acre unit for production of gas from the Warren-Blinebry Gas Pool.

- A plat showing to the best of our knowledge and belsef the 2. location of the No. 10 well, other wells on the lease, offset wells and the ownership thereof. The plat shows that applicant is the operator of all acreage directly offsetting the proposed gas unit.
- 3. A radioactivity log of the well with the tops and bottoms of producing zones and intervals to be perforated indicated thereon.

The granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein, it is respectfully requested that the Commission enter an order approving the proposed dual completion as described above. -
