The subject wall on front east produced 22 ft. 1 in with no more by the lift.

we propose to install Parker type line pipe equipment in the following manner: Pull 1 1/2" packer & flow valve and clean out to 9131'; run air hole per second part at 9135' and pump in 2 bbls filtered condensate fol by 1/2 bbl methanol, then 1 bbl filtered condensate, then 1 bbl water condensate then one bbl (T-19) fol by 3 bbls filtered condensate; repeat previous treatment for each of the other packers and intervals at 9295, 9067, 9054, 9037, 9008 & 8942'; all intervals were & again clean out to 9131'; run millstone 14-20 per, seating nipple, stem line valve, perforated nipple, 200' of 2" lgs, Brown by-pass per, clamp 1/2" 100' lateral with second Brown & valve, one ft of lgs, natural & flow valve, 200' lgs, natural & flow valve and 1" lgs to surface. Set lower per at approx 8940'. Connect to present and supply system, as & if necessary & place on production.
