12-5-90 BIH w/left hand collar + 2 7/8" WS. Continue in hole w/2 7/8" tbg. Screw onto AD-1 pkr at 5707. BIH w/4 3/4" bit, 5 1/2" scraper + 2 7/8" tbg. Establish circ + Co iron sulfide scale from 5904 - 6082 (PBD). Wash Blinbury perf + open hole section (5800-6011) w/1500 gals 2%. KCL wtn, taking returns to pits. Wash perf + open hole w/1500 gals 15% HCL-NE-FE acid w/csg valve closed. BIH w/5 1/2" pkr + 2 7/8" tbg. Set pkr at 5708. Pres up csg to 500#. Acidize Blinbury perf (5800-6082) w/5000 gals 15% HCL-NE-FE acid + 100 BBL Di-chlor. Flush w/40 BBL wtn. AIR 2 BPM at 2300#. RD. BT SI for 1 hr. POH laydown 2 7/8" WS. Change out 1000 in BOP. BIH w/5 1/2" pkr + 190 jts 2 7/8" P.C. tbg. Circ pkr fluid. Circ 130 BBL pkr fluid + WD BOP. Land pkr at 5707. Pres + t csg to 500# for 15 min - OK. Place well on injection.
