We plan to fill the hole with heavily laden mud and run a 25 sack cement plug at total depth, shoot casing loose and run a 25 sack cement plug in the stub of 5-1/2" casing; run a 15 sack cement plug in the bottom of the 8-5/8 at 3281', run a 10 sack cement plug in the bottom of the 12-3/4" at 315'; a 15 sack cement plug in the top and put a 4" marker, leaving it extended 5' above the ground level.
