2. Cleaned out sand to 4021' Ran 2 1/16" Plastic Coated Tubing and 5 1/2" x 2" Larkin Type 95 Tension Packer, on 123 jts 2 1/16" Plastic Coated Tubing and set packer at 3843'. 3-3-1963.
3. Connected up well for water injection commencing 3-4-1963 at 5:00 PM.


