Gentlemen:

The following is an application for a No-Flare Order to be assigned to the Western Drilling Company, Inc. No. 1 Donegan-State (Humble), location is Unit D, Section 3, T-22-S, R-35-F, Jalmat Pool, Lea County, New Mexico.

This well was completed December 14, 1959 and was potentialed for 36 barrels oil plus 12 barrels water in 24 hours. The latest test on this well shows it to be producing by pump 21 barrels cil plus 8 barrels water with a gas-oil-ratio of approximately 4,000 CFPB. After contacting the companies who have gas gathering lines near this area, it has been found that, at the present time, a gas connection for casinghead gas is unobtainable. It was suggested by these companies that if further development in this area produced sufficient gas, they would then connect this well. Future drilling is anticipated by Western Drilling Company, Inc. in this area and a connection may possibly be obtained in the near future. It is requested at this time that a No-Flare Order be issued on this well.
