October 28, 1987: Pulled tubing & packer ran Halliburton E.Z. Drill bridge plug to 3546'. Found casing leak 570-635'. Spotted 200 gallons 15% acid. Braiden head squeeze 200 SX class "C" cement. SD; tag cement 284', drilled cement to 650'. Ran Baker AD-1 to 3941' pressured to 300 PSI for 30 minutes with no pressure loss. Return to injection.
