2. Cleaned out to 4055', 9-2-1962.
3. Ran dual tubing strings as follows: 1st String: 5½" x 2 1/16" packer, 4 Jts. 2 1/16" tubing, 5½" x 2 1/16" packer, 120 Jts. 2 1/16" tubing. Set bottom packer at 3939' and top packer at 3803'. 2nd String: 2 1/16" mandrel, 119 Jts. 2 1/16" tubing. Set tubing at 3803' bottom of mandrel. 9-3-1962
4. Connected well to water injection well commencing 9-17-1962.
