Gentlemen:

This is to request that the fill Conservation Commission grant a 320 acre non-standard gas proration unit subracing the SE/4 of Section 24 and the NE/4 of Section 25, T228, R35E, Lea County, New Maxico and the allowable be assigned to the Amerada State #1 gas well.

You will recall that by our letter dated July 15, 1959 we requested that NSF Order R-762 be suspended and the ussigned acreage for the above mentioned well be confined to 160 acres. Subsequent production has indicated that this well is capable of producing more than one unit allowable, therefore, we are requesting that it be returned to a 320 acre unit allowable.

In support of this request we wish to state the following:

- 1. The Amerada State No. 1, located 660' FEL and 1980' FSL of Section 24, T228, R35E, has been completed as a gas well from within the vertical limits of the Jalmat Gas Pool.
- 2. The proposed 320 acre non-standard gas proration unit consists of two adjoining quarter sections which are no longer than 5,280° in any dimension and the entire unit area may reasonably be presumed to be productive of gas.

3. All operators owning interest adjoining who proposed unit have been furnished copies of this
application by certified mail.

 A gas proration plat of the area indicating the proposed non-standard gas proration unit and offset ownership is attached.

An exception to Sule 3-A. Order 4-520, permitting the assignment of 320 acre non-standard gas provation unit to this well is requested.
