Cemented with 1700 sacks of 50-50 sacks ~~Benmix~~ with 6% gel and 1/2# of Flocele per sack followed by 200 sacks of regular neat. Plugdown at 2:30 PM 12-18-56. Cement circulated. WOC 24 hours. Tested casing with 1000# from 8:30 to 9:30 PM 12-19-56. Test OK.
