Permission is hereby requested to install flow valves and connect outside gas for gas lift at our H. T. Mattern "E" No. 1. The outside gas will be from the Eunice Gas System. The Eunice Gas System receives gas from W. A. Ramsay #1 gas well, which produces from the Yates and Seven Rivers formations; and from our H. T. Mattern #1 gas well, which produces from the Queen and Grayburg formations. The W. A. Ramsay #1 gas well is located in SW $\frac{1}{4}$ of Sec. 34, Twp. 21S, Rge. 37E. The H. T. Mattern #1 gas well is located in SE $\frac{1}{4}$ of Sec. 24, Twp. 21S, Rge. 36E.
