DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Lufkin TC-2BT-35B-10217 CH unit w/15 HP electric motor, ran 120 joints 3747' of 2-7/8" tubing. Tubing set at 3758', seating nipple at 3747'. Perforations 3749-3751'. Ran pump and rods.

RESULTS: Pumped on Oil Conservation Commission test 80 bbls oil 235 bbls water thru 2-7/8" tubing in 24 hours, 18 x 52" SPM. Formation gas volume 156,900 cu.ft. GOR 1956/1. Average daily production for October 1952 22 bbls oil 201 bbls water. Allowable before installing pumping unit 19 bopd. Allowable after installing pumping unit 45 bopd.
