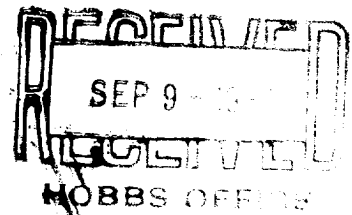

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On Sept. 6, 1938 ran 120 joints of 6" OD 16# 10-thd. SS casing, Grade "D", 116 joints new, 4 joints second hand, set at 3695'. The casing was cemented with 350 sacks 4% aquagel cement and 50 sacks neat cement. Plug was pumped to 3657'.

We propose to drill the plug and test casing shut-off at 245 PM, Sept. 8, 1938.
