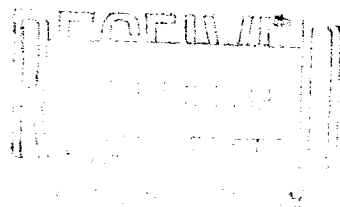

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

7-5/8" OL casing was set in the subject well at 1434', cemented with 425 sacks and cement allowed to set 72 hours, after which time casing was tested with 1200# pressure for 30 minutes both before and after drilling plug. Casing tested OK.
