5-1/2" OD casing was set in the subject well at 3715' and cemented with 900 sacks on May 21, 1940.

Cement was allowed to set 72 hours, after which time casing was tested with 1200# pressure for 30 minutes both before and after drilling plug. Casing tested OK.
