DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Subject well was plugged and abandoned in the following manner:

1. Set 50' cement plug on bottom 3572-3522'.
 2. Set bridge plug at 2800' and squeezed with 50 sacks cement.
 3. Shot off 5 1/2" casing at 820', recovered 815'-0".
 4. Spotted 100' cement plug from 770' to 870'.
 5. Spotted 50' cement plug from 50' to surface.
 6. Erected 4" x 4" Steel marker set in cement at surface.
- The intervals between the cement plugs were filled with 12# mud.
