POH with rods and pump. Close in South Eunice 24 hours. Obtain SI BHP and 100' gradient pressures on South Eunice; record surface shut in pressure. Set plug at 3725'; test plug 500#. GIH, open circulating valve at 3706'. Close in Jalmat 24 hours. Obtain SI BHP and 100' gradient pressures on Jalmat; record surface shut in pressure. GIH, close circulating valve. Fish plug. GIH with rods and pump; hang well on.
