gas 360,000 cu. ft. cutting 10% water.

Production After:- Flowed 72 barrels oil in 18 1/2 hours thru 2" tubing wide open,
well shut in 4 1/2 hours before starting test.

June 28th, 1943 re-acidized with 2,000 gallons 15% Acid.

Production after:- Flowed 129 barrels oil and no water in 24 hours thru 2" tubing wide open
Witnessed by gas 315,000 cu. ft. GOR 2,442.
