DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Pulled tubing. In cleaning out, the sand pump got stuck at 3845' and broke the sand line. The bailer was fished out with a three prong grab. Then 3871' of 2" tubing was run back into the hole and the packer set at 3629'. The well was treated with 1,000 gals. of Gel acid and 4,000 gals. of 15% acid.

Test before treatment: 3 BOPD 0 BWPD
Test after treatment: 20 BOPD 1 BWPD
