Texas Pacific Oil Company respectfully requests administrative approval, under the provisions of Rule V (c) of Order R-1670, for the formation of a 160 acre non-standard gas proration unit for its State "A" A/c-2, Well No. 44, located 1980' F&L and 1980' F&L of Section 5, T-22-S, R-36-E, Lea County, New Mexico.

The 160 acres to be dedicated to this unit will consist of the NW/4, Section 5, T-22-S, R-36-E. In support of this application the following facts are offered:

1. The proposed unit consists of 160 acres being less than the standard 640 acres unit for the Jalmat Pool.
2. The proposed unit consists of contiguous quarter-quarter sections, all within a single governmental section.
3. The proposed unit may reasonably be presumed to be productive of gas.
4. The proposed unit does not exceed 5280' in length or width.

4. The proposed unit does not exceed 2880' in length or width.
5. Copies of this application have been furnished this date to all other operators and all operators within 1000' of said well.

The said well presently has 120 acres of the proposed 160 acre unit dedicated to it and this application is merely to add an additional 40 acres. The 40 acres to be added previously was dedicated to a Jalmat oil well (Texas Pacific Oil Company's State "A" A/c-2, No. 35) which has been recompleted to the South Basin Pool.
