Raptor Resources, Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

Raptor Resources, Inc. is planning to re-complete it's State "A" A/C 2 Well No. 21 in the Jalmat Tansil Yates 7-Rivers (Pro Gas Pool. We request the increasing the size of the existing 393.06-acre GPU by 40 acres to include the SW/4 SE/4 Unit O of Section 7. It is our desire to also simultaneously dedicate the existing 433.06-acre Proration Unit assigned to our well nos. 5, 8, and 19 to all four wells. Previously approved orders are R 9073, well no 8 is currently carried as temporary abandon and well no 9 is assigned the 40 acre proration Unit (SW/4 NE/4 Unit G) of section 7 as a producer in the Jalmat Tansil Yates 7-Rivers Oil pool.

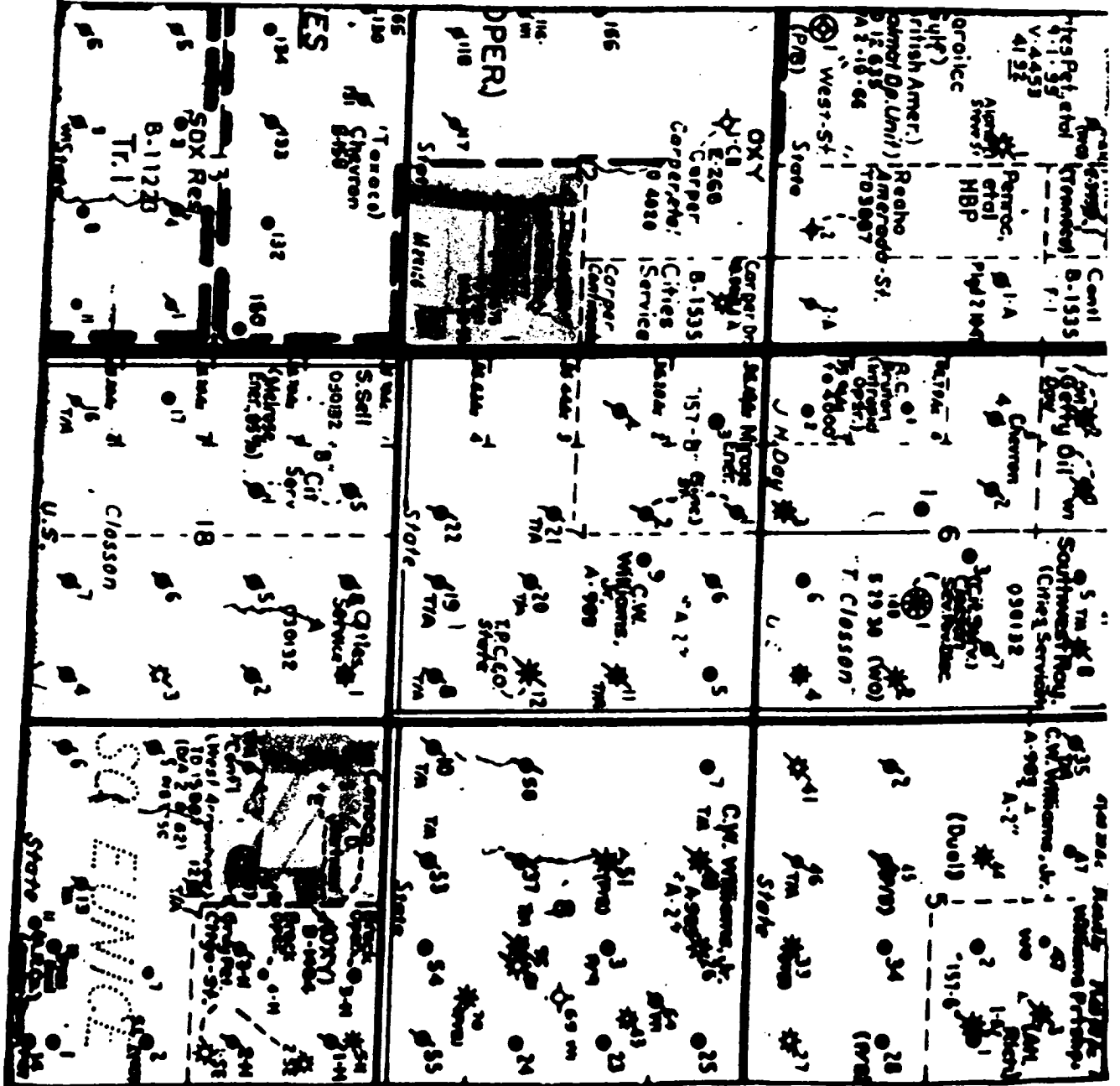

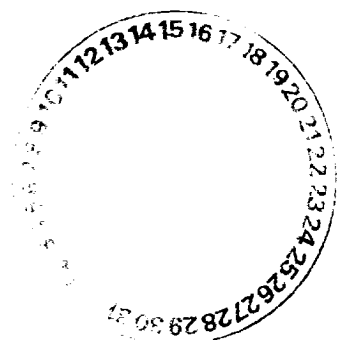

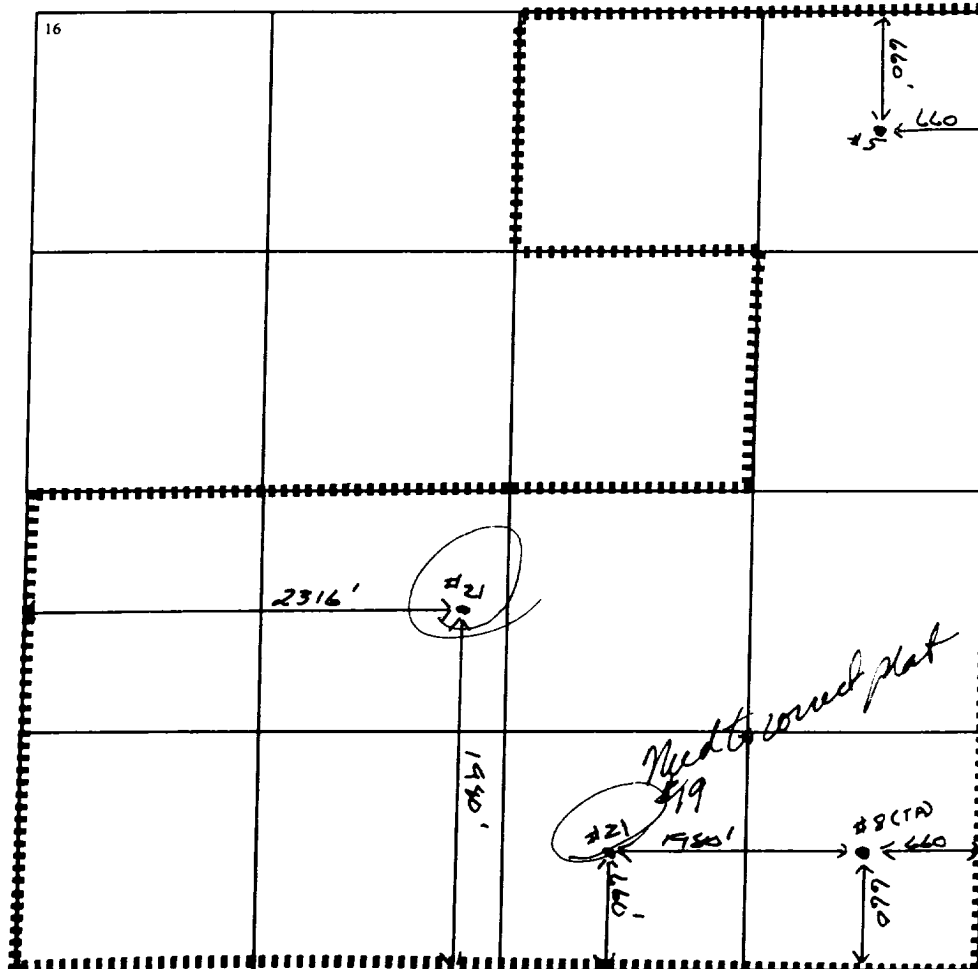
