FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods and tubing.
2. Run 2" tubing, bit and clean out to 3889' (-305')
3. Run 180° 4-1/2" 10.5# J-55 casing Liner. Set at 3889'. Cement w/50 sks. Latex Cement.
4. Run Gamma Ray - Neutron log from surface to T.D.
5. Perforate selected intervals single entry. Run 3" tubing and FB cementer.
6. Acidize w/1000 gal. acid and ball sealers. SOT w/40,000 gal oil, 40,000# sand, 1/40# Adomite/gal. Pull 3" tubing and packer. Run 2" tubing.
7. Swab test.
